

## Industry Updates – Q4 2018

### Food & Beverage Industry – North America

#### **Market Update**

The food & beverage M&A market remained active throughout 2018. The last quarter of 2018 saw about 102 transactions in comparison to 101 transactions in the last quarter of 2017. 2018 marked a total of 358 transactions in comparison to 373 transactions in 2017.

Some of the notable transactions in quarter 4 of 2018 were the acquisition of The Schwan Food Company by CJ CheilJedang for US\$2.3 billion and acquisition of Kraft Heinz's Canadian natural cheese business by Parmalat for US\$1.2 billion.

There are a variety of opportunities for growing food and beverage businesses in 2019, but staying on top of emerging technologies like blockchain, along with changing consumer preferences and rising costs, all while innovating, will be essential in this competitive marketplace.

As consumers demand to know more about the food they eat, food safety issues are costing the food and beverage industry billions each year. It will be more important than ever for the industry to pinpoint safety issues immediately; technologies like blockchain will continue to gain traction. Companies will move beyond trying to understand what blockchain is, to figuring out how to be a part of it. A 2018 RSM survey of middle market food and beverage chief financial officers found that just 12.0% are currently using blockchain, but that number will increase as more become aware of blockchain's benefits across the entire food chain—from the grower to the manufacturer, distributors and beyond. What truly differentiates blockchain from other technology solutions is its design, which provides immutable verification in a network where not all actors trust each other. This valuable feature identifies accurate sourcing, mitigates fraud and enables better confidence among all partners and consumers. [Link](#)

2019 will inspire focus on sustainability, health and wellness, and convenience in food formulation. Jenny Zegler, Associate Director, Mintel Food & Drink quotes : *"In 2019, support of and demand for more corporate sustainability programs will grow as consumers better understand what's required to get closer to achieving a truly circular food and drink economy. These sustainability efforts will include not only improving access to recycling, but creating products with ingredients that are grown in accordance to regenerative agriculture practices"* [Link](#)

2019 also brings with it the requirement for the preparation needed to meet two landmark labeling changes taking effect on Jan. 1, 2020. Those would be the new Nutrition Facts panel, with its call-out of added sugars, and GMO labeling or "bioengineered" or BE. [Link](#)

### **Trends to watch out in 2019**

#### **Cannabis-Infused Food and Beverages**

With legalization of Cannabis in North America and other parts, cannabis infused food and beverage is a trend to watch out in 2019. The State of Legal Marijuana Markets report from Arcview Market Research and BDS Analytics projects retail sales of legal cannabis will climb from 2017's \$9.2B to \$24.2B in 2021—an impressive 27% CAGR. Many beverage behemoths are already positioning themselves for the growing trend. Last year, Constellation Brands, the company behind Corona Extra Modelo Especial and SVEDKA Vodka, announced it had bought a 9.9% stake in Canadian cannabis producer Canopy Growth Corporation. At the same time, Keith Villa, founder of Blue Moon beer, announced that he was launching a non-alcoholic, THC-infused beer company called Ceria Beverages. [Link](#)

#### **Gut-Friendly Food**

With fermenting, pickling and preserving reaching the mainstream, gut health has established itself as a key trend to watch out in 2019.

Products designed to enrich digestive health are extending well beyond the yogurt aisle. If the past few years are any indication, digestive health will continue to grow and expand as a category over the next year. BCC Research expects that probiotics alone will reach a \$50 billion market by 2020.

No longer just the business of the yogurt aisle, they have appeared in fruit juice, pet food and gluten-free brownies. [Link](#)

The trend has also received the seal of approval from food and beverage behemoths like the Coca-Cola Company when it acquired kombucha maker Organic & Raw Trading Co., which makes the MOJO brand of naturally-fermented, live culture, drinks, signaling the fast-emerging trend. [Link](#)

#### **Moderation**

With 'Dry January' around the corner, many consumers will be forfeiting their favourite tipple for a month in aid of their health. Yet, growing research has shown that, for an increasing number of people, it could be an entirely dry year as low – and no-alcohol drinks become a more common lifestyle choice. In the UK alone, more than 1.4mn UK households bought a no – or low-alcohol beer in the last year - a 57% increase on two years ago, according to Kantar Worldpanel. Beverage companies, mixologists and supermarkets are increasingly embracing the low-alcohol and no-alcohol trend too. Heineken, Adnams, and Guinness are just some beverage giants that have launched no – and low-alcohol beers this year [Link](#)




